Vendor Regulations - PLEASE READ CAREFULLY

In order to maintain a well-balanced, well-organized, and successful Craft Show, we appreciate your cooperation with the following regulations.

Booth: Vendors are responsible for delivery, setup, removal, and the safety and cleanliness of their exhibits and the immediate surrounding area. *Vendors must provide their own tables, canopies, and any necessary means to secure canopies.*

Subletting Spaces: Vendors may not sublet any portion of their assigned space or display goods, equipment, or literature unrelated to the items approved for sale.

Payment for Booth(s): Any prospective vendor who fails to submit full payment or who cancels their reserved space forfeits all monies paid and all rights to the contracted booth. 970.Church reserves the right to reassign or resell forfeited space as it deems appropriate and will have no liability for such reassignments. Payments must be mailed to: 970.Church, 2711 Unaweep Ave., Grand Junction, CO 81503.

Sales Tax / Licenses: Vendors are solely responsible for obtaining any required permits or licenses and for collecting and remitting all applicable state and local taxes.

Liability: Neither 970.Church nor its employees, board members, volunteers, congregation, or agents shall be liable for injury, loss, theft, or damage to vendors, their representatives, their property, or their merchandise before, during, or after the Craft Show. Vendors assume full responsibility for their displays and activities and, by signing this form, expressly release and indemnify 970.Church and its representatives from any claims arising from injury, theft, or damage.
