PROJECT TITLE

Mount Hope Family Life Center (Gym) – Activities and Accessible Fitness and Nutrition Programs for All Ages: Children, Youth, Adults, and Seniors

INTRODUCTION

Mount Hope Assembly is a Christian community-focused organization dedicated to serving the spiritual, social, mental and physical needs of people by developing programs and activities for people of all ages. Established in 1926 as Wickenburg Assembly of God, and moving to its present location in 2000, it has always been the vision to have three buildings on the property. One is a building dedicated to have a place to make physical fitness and afterschool programs available for everyone, regardless of their age and provided all year round.

PROBLEM STATEMENT

1. Despite the growing awareness of the importance of physical fitness for all ages, many individuals in our community face barriers to accessing quality fitness facilities and programs. These barriers include high membership costs and limited availability of specialized programs for different age groups and abilities. As a result, many community members are unable to engage in regular physical activity, leading to health disparities and a decline in overall well being.
2. In Arizona, the summer heat limits many from outdoor activities, and an indoor space is the best alternative.
3. Many children and youth cannot afford the cost of local sports programs and travel costs related to it. Some have no place to go between the time school releases them and their parents coming home from work.
4. Wickenburg, as a community, currently lacks large venues capable of accommodating large groups.

PROJECT DESCRIPTION

The proposed project aims to address these challenges by constructing a building that features a standard size gym floor with lines for basketball, volleyball and pickleball. Additionally, the facility will include a commercial kitchen, bathrooms with showers, classrooms and a physical fitness room. These amenities will support the development of various programs and make them more accessible to underserved populations and our church community.

The project will include:

1. **Open to the Public** supervised activities by trained, background checked church members who are dedicated to helping the different age groups.
2. **Specialized Programs:** Develop and implement specialized fitness programs for seniors, adults, youth, children, and individuals with disabilities.
3. **Community Outreach:** Conduct outreach initiatives to raise awareness about the importance of physical fitness and the available resources and programs we offer. We would also like to host the local public and private school's awards banquets and fund-raising dinners.

GOALS AND OBJECTIVES

1. Securing the necessary funds for constructing the building
2. Providing a Safe Place for Children and Youth
3. Once the building is built, Launch a tutoring program, fitness programs for young and old within the first six months.
4. Secure funds for operating expenses, supplies, staffing and equipment.
5. Explore the possibility of lunch program during the summer break for kids in need, with USDA Summer Food Service Program or the Arizona Summer Food Service Program.

EVALUATION PLAN

To measure the success of the project, we will use the following evaluation methods:

1. Track the number of people served, their name and contact information each quarter to report to the board of directors, and yearly to ongoing investors.
2. Monitor attendance and participation rates in specialized programs.
3. Collect feedback from participants through written surveys placed in comment box and interviews.

PROJECT COST

The estimated cost of the new gym is approximately \$2.75 million, which includes site preparation, construction, materials, labor, permits, utilities, and essential interior systems like lighting, flooring, HVAC, and restrooms. It also reflects current market construction costs and a contingency to ensure the project is completed responsibly and without financial strain.

SUSTAINABILITY

To ensure the long-term sustainability of the project, we will pursue additional funding opportunities, partnerships with local businesses and organizations, rental for some outside groups and ongoing fundraising efforts such as tournaments and dinners. We are also committed to continuously evaluating and improving our programs to meet the evolving needs of our community.

CONCLUSION

By supporting this project, you will be contributing to the overall health and well-being of our community members, helping to break down barriers to fitness, and promoting a healthier, more active lifestyle for everyone. I fully support this project and encourage you to provide grant money to help meet the significant needs in our community for improved health and well-being.

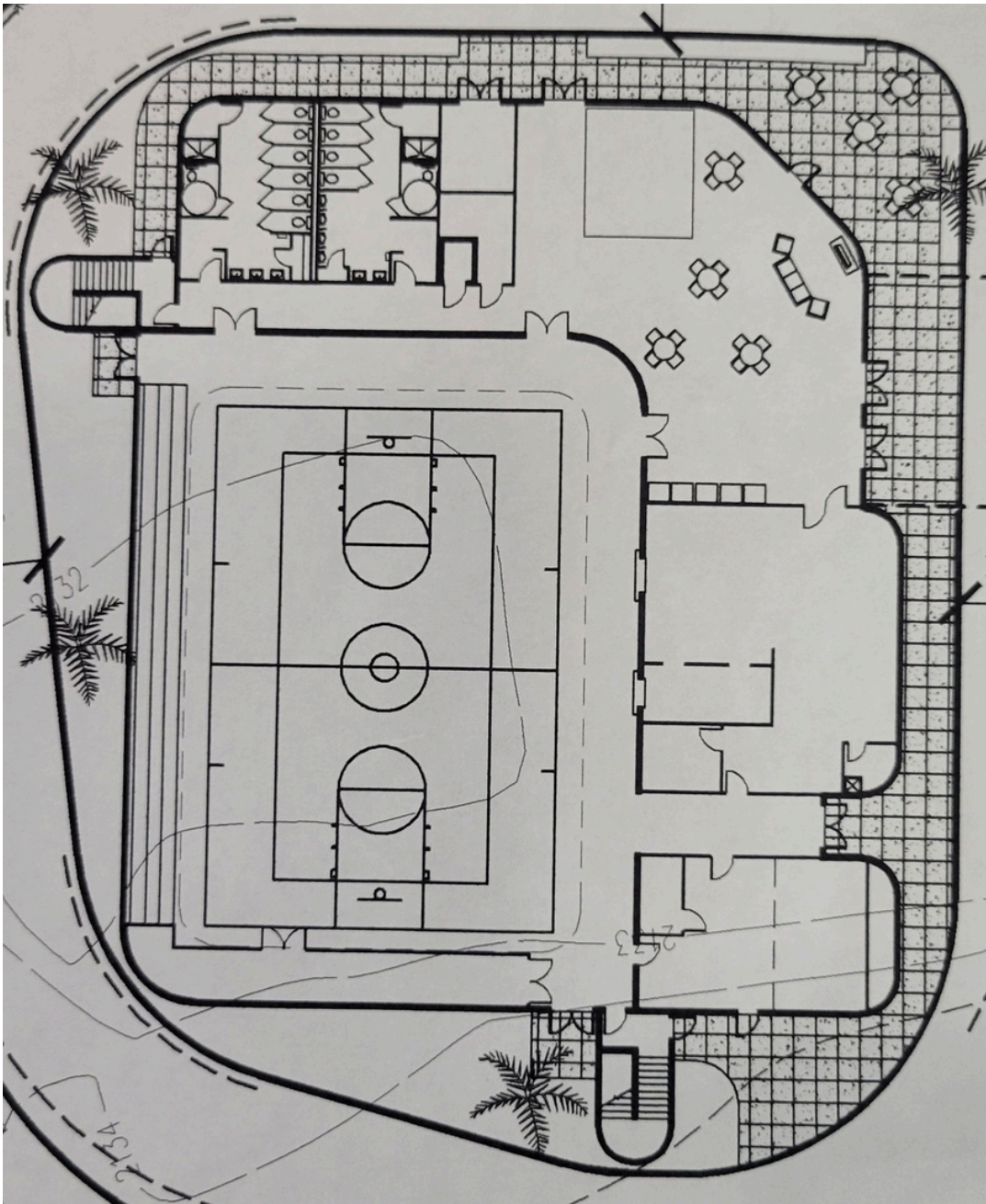

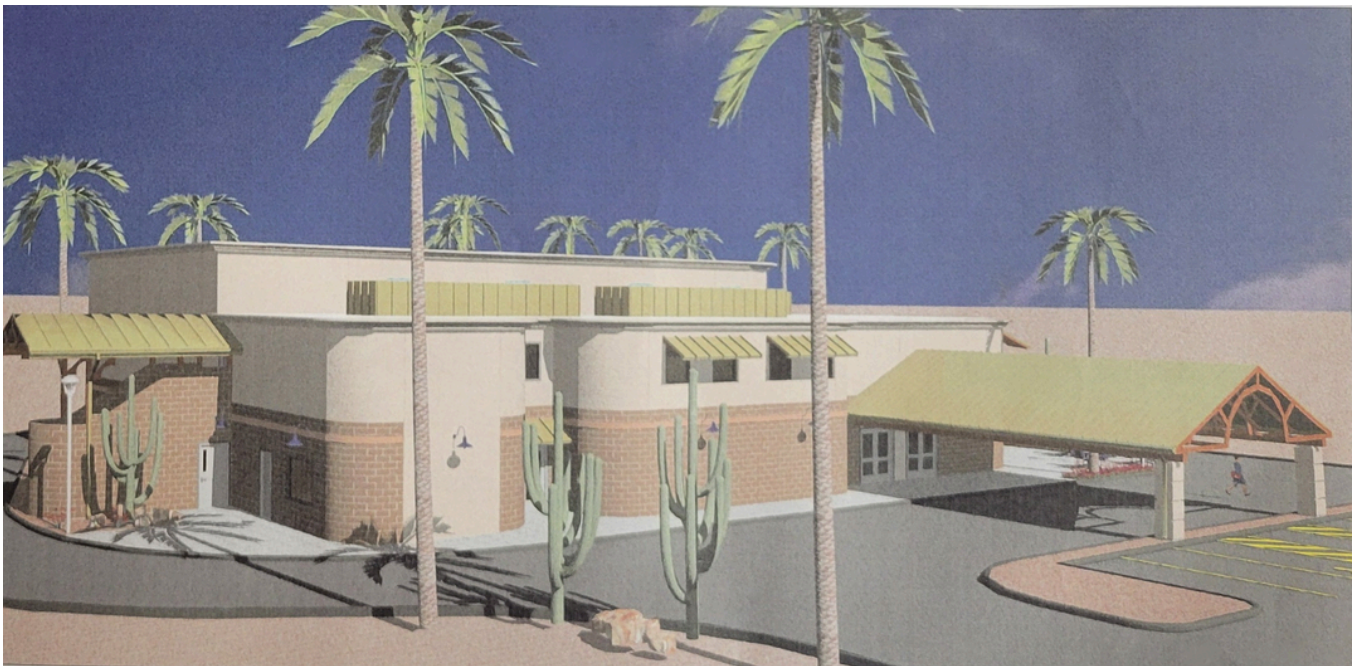
FLOOR PLAN
