

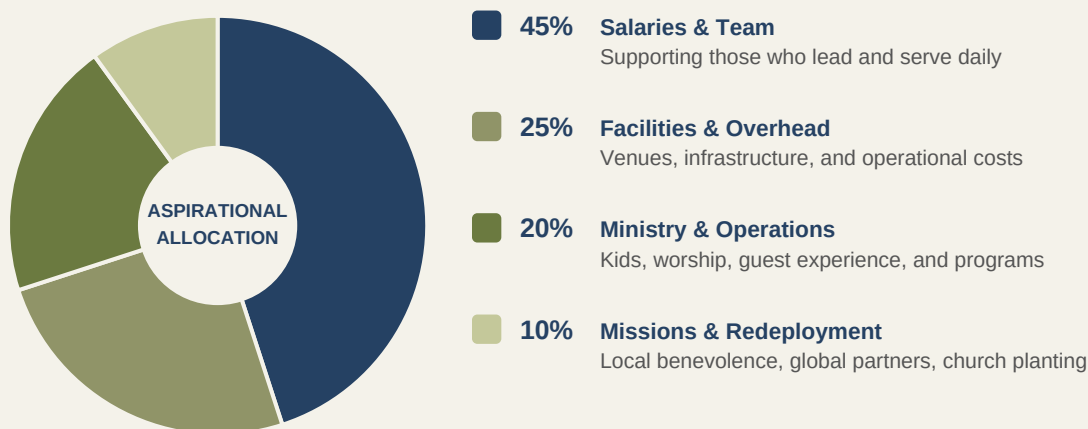

## FINANCIAL STANDARDS

### How We Handle What You Trust Us With

#### INDEPENDENT REVIEW

Our financials are managed by The Parable Group, a third-party accounting firm, providing an extra layer of professional diligence entirely separate from church leadership.

#### MISSIONS AND REDEPLOYMENT FIRST

Ten percent of our total budget is committed before the first operational dollar is spent, directed to local benevolence, global partnerships, and future church planting.

#### BOARD OVERSIGHT

A dedicated Board of Trustees, separate from pastoral leadership, approves all major expenditures. No single person controls financial decisions.

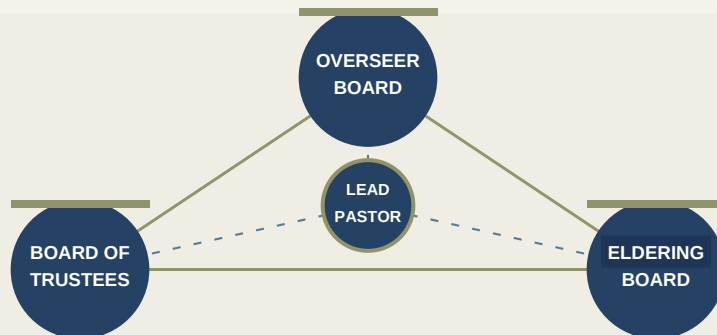
#### AUTONOMOUS AND ACCOUNTABLE

## GOVERNANCE STRUCTURE

## Three Boards. One Mission. No Single Point of Control.

Way Church operates under the Triangle, a three-board governance structure that keeps spiritual leadership, financial oversight, and missional accountability in distinct, healthy tension. The Lead Pastor sits at the center, leading the staff team to execute the ministry vision. Way Church is an autonomous congregation, independent of any denominational hierarchy.
