

**RELEASE, INDEMNIFICATION, AND HOLD HARMLESS AGREEMENT
(MINORS FORM)**

We, the parents and/or guardians of the minor child, _____, being _____ years of age, hereby give permission for the minor child to attend Fielder Church Camp ("Summer Camp") administered by Fielder Church ("Camp Administrator") and held at the Riverbend Retreat Center ("Center") in Glen Rose, Texas. We recognize and understand that the child will be participating in activities which may expose the child to some level of risk of injury. We acknowledge that the minor child will be participating at his/her own risk.

Furthermore, we understand that unless we have notified the Camp Administrator or the Center in writing that the minor child is unable to participate in an activity due to some physical or mental consideration, the child will be allowed to participate in all activities at the Summer Camp.

We give our permission for our child to participate in any on-campus field trips planned and taken as a part of the Summer Camp. We understand and agree that these trips may involve transportation by van or walking.

In consideration for the minor child being permitted to participate in the Summer Camp during the month of June 2026, the undersigned, acting on behalf of ourselves and our minor child, and any heirs or assigns ("We"), hereby waive and release forever any and all rights for claims and damages We or our minor child may have against Dallas Baptist University, its Board of Trustees, its current and former Trustees, officers, directors, agents, employees, or representatives, the Center and the Center's owners, officers, agents and employees, and the Camp Administrator, the Camp Administrator's owners, officers, agents and employees, from and against all loss (including reasonable attorneys' fees) from any and all claims of ordinary negligence, demands, liabilities, rights, or causes of action of any kind or nature that may be brought by or on behalf of the minor child or me arising out of any and all known or unknown, foreseen and unforeseen bodily or personal injuries, damages to property and consequences thereof which may be sustained by the minor child or me arising out of or in connection with the minor child or my participation in the Summer Camp, including but not limited to the travel to, from, and around the Center, except such liability or claim of liability as may result from gross negligence or intentional misconduct on the part of the Camp Administrator or the University. Furthermore, we agree to indemnify Riverbend Retreat Center for any loss or damage to the premises, facility, or equipment of the Center caused by our minor child. Such indemnification shall include costs and expenses incurred by the Center, including reasonable attorneys' fees.

We accept, understand, and assume that there is a risk of injury in our child attending this Summer Camp, due, in part, to the physical nature of many of the Summer Camp activities, including, but, not limited to, falls or contact with other participants. Activities at the camp

include but are not limited to: being hit by a ball, bat, or other equipment; colliding with players, staff, spectators, facilities, or equipment; sustaining injuries from using campus swimming pool; transportation accidents; actions of instructors, counselors, participants, and other people; and injuries from sun, lightning, and similar hazardous weather condition.

CAUTION: READ BEFORE SIGNING:

I understand that I am entitled to have an attorney of my own choosing review this release prior to signing. I have read the foregoing release and understand that I am signing a complete release and bar to any and all claims of ordinary negligence as defined above resulting from my participation in this activity.
