

**RELEASE, INDEMNIFICATION, AND HOLD HARMLESS AGREEMENT
(ADULT FORM)**

In consideration of being allowed to participate, I, _____, the undersigned, being 18 years of age or older, understand, acknowledge, and agree to as follows:

I would like to attend Fielder Church Camp ("Summer Camp") administered by Fielder Church ("Camp Administrator") and held at the Riverbend Retreat Center ("Center") in Glen Rose, Texas. I recognize and understand that the camp activities may expose me to some level of risk of injury. I acknowledge that I will be participating at my own risk.

Furthermore, I understand that unless I have notified the Camp Administrator or the Center in writing that I am unable to participate in an activity due to some physical or mental consideration, I will be allowed to participate in all activities at the Summer Camp.

I understand I may participate in any on-campus field trips planned and taken as a part of the Summer Camp. I understand and agree that these trips may involve transportation by van or walking.

In consideration for me being permitted to participate in the Summer Camp during the month of June 2026, the undersigned, acting on behalf of myself and any heirs or assigns ("I"), hereby waives and releases forever any and all rights for claims and damages I may have against Dallas Baptist University, its Board of Trustees, its current and former Trustees, officers, directors, agents, employees, or representatives, the Center and the Center's owners, officers, agents and employees, and the Camp Administrator, and the Camp Administrator's owners, officers, agents and employees, from and against all loss (including reasonable attorneys' fees) from any and all claims of ordinary negligence, demands, rights, liabilities, or causes of action of any kind or nature that may be brought by or on behalf of me arising out of any and all known or unknown, foreseen and unforeseen bodily or personal injuries, damages to property and consequences thereof which may be sustained by me arising out of or in connection with my participation in the Summer Camp, including but not limited to the travel to, from, and around the Center, except such liability or claim of liability as may result from gross negligence or intentional misconduct on the part of the Camp Administrator or the Center. Furthermore, I agree to indemnify Riverbend Retreat Center for any loss or damage to the premises, facility, or equipment of the Center caused by me. Such indemnification shall include costs and expenses incurred by the Center, including reasonable attorneys' fees.

I accept, understand, and assume that there is a risk of injury for me attending this Summer Camp, due, in part, to the physical nature of many of the Summer Camp activities, including, but, not limited to, falls or contact with other participants. Activities at the camp include but are not limited to: Activities at the camp include but are not limited to: being hit by a ball, bat, or other equipment; colliding with players, staff, spectators, facilities, or equipment; sustaining

injuries from using campus swimming pool; transportation accidents; actions of instructors, counselors, participants, and other people; and injuries from sun, lightning, and similar hazardous weather condition.

I understand that this Summer Camp is not administered or directed by Dallas Baptist University or Riverbend Retreat Center and that the Camp Administrator is providing the instruction and camp activities outside the scope of any affiliation with Dallas Baptist University or the Riverbend Retreat Center.

CAUTION: READ BEFORE SIGNING:

I understand that I am entitled to have an attorney of my own choosing review this release prior to signing. I have read the foregoing release and understand that I am signing a complete release and bar to any and all claims of ordinary negligence as defined above resulting from my participation in this activity.
