Highlights

- We completed work on the 2025 budget in November and December. Our goal was to have a balanced budget. Due to less than expected income, the only way to reconcile the budget was to make some cuts and reduce our payment for apportionments. Our apportionments support the wider ministries of the United Methodist Church. Apportionments support the church-wide budget to conferences and local churches. In addition to various charities, missions and administrative issues, they also support clergy pensions and benefits. SUMC has always placed high importance in paying our apportionments. During 2025, we will periodically review our financial situation and try to fully pay our apportionments.
- The Loudoun County Sherriff Office provided a second safety and security training program on active violence incidents in November. The training provided information about active violence incidents, law enforcement actions and how we should react in such situations. It will support development of a Safety Team next year.
- Regarding the 150TH Anniversary, due to the busy Advent season, we decided not to meet again until early in 2025.

Highlights

- Several church keys have been returned. To secure the church building we highly recommend using the alarm system beginning October 1, 2024, every night.
- We are reviewing dead bolts to put on doors to best secure rooms.
- We are waiting to hear back from Whereipark regarding the potential to rent 25 parking spaces at SUMC between 6 am and 5 pm, Monday thru Friday. This would provide our church with additional income.
- The former renter of the parsonage was released from their contract due to medical issues. New renters moved in November 2024.
- There was a slight increase in rent to ensure we have funding for parsonage repairs when needed.
- Parsonage items were fixed from the move out inspection.
- New tenants signed Nov. 29, 2024 for 2 years thru Nov. 29, 2026.

- Church roof drains were cleaned to prevent leaks.
- We are working to replace the Jacobus Center basement rear door. The current door is falling apart.
- A church walkthrough was conducted by Trustees on October 27, 2024 to identify maintenance items to track and care for.
- Additional Trustees will be added for 2025.
- Patching of some potholes in the parking lot was done. We applied for a grant to repave the parking lot and replace some windows. Grants are expected to be announced in March. If we receive the grant, we will try to get the parking lot done in the spring.

Highlights

Final 2024 Budget Report

- Final 2024 income initially came in at \$43,565.69 above our budgeted break-even point. The primary reasons were:
 - > \$20,800 in above-projected donations and rent from KUC
 - ➤ \$11,167 in above-projected unrealized investment gains
 - ➤ \$5,513 in above-projected Christmas offerings
 - ➤ \$5,233 in above-projected realized investment gains
 - > \$5,156 in above-projected stock offerings
 - > \$3,488 in above-projected summer camp earnings
 - > \$1,200 in above-projected Lenten offerings

- ➤ approximately \$20,000 in below-projected operating expenses
- Note that our pledge and plate offerings came in about \$37,000 <u>below</u> our projection for the year, but the above items more than made up for this, and yielded a surplus.
- This surplus income allowed us to pay \$37,000 toward our 2024 apportionment fees, bringing our total apportionment fees paid to \$110,453.80, which was 96.4% of our total apportionment fees owed.
- The surplus also allowed us to put \$2,000 into the Visibility Fund, \$1,500 into the Pastor Relocation Fund, and maintain \$3,065.69 as retained earnings. Th retained earnings can be reallocated in the future to meet our needs.

January 2025 Financials

- Total income is \$41,531. This is 8.41% of our total budget (almost exactly 1/12)
- Total expenses are \$47,706. This is 9.03% of our total budget. Among the reasons for higher-than-normal expenditures are January snow removal and a number of annual subscriptions that renewed in January.
- There was a net operating loss for January of \$6,174.
