RESTATED ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 10-3A-84, Code of Alabama, 1975, First Baptist Church of Huntsville, Alabama, by a resolution duly adopted by its membership, hereby adopts the following Restated Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation shall be the First Baptist Church of Huntsville, Alabama.

ARTICLE II

TIME LIMIT

The time period of this corporation shall be perpetual.

ARTICLE III

OBJECTIVES

The corporation is formed as a spiritual body that is affiliated with the Southern Baptist Convention and Alabama Baptist State Convention and accepts the statement of "The Baptist Faith and Message" as adopted by the Southern Baptist Convention in 1963.

ARTICLE IV

MEMBERSHIP

The members of the corporation shall be the members of First Baptist Church of Huntsville, Alabama.

ARTICLE VGOVERNANCE OF THE CORPORATION

There shall be no Board of Directors of the corporation. Governance of the corporation shall be by the membership. A Board of Trustees, Deacon Body, Church Officers, Church Committees and the Church Staff shall carry out the duties decided on by the membership.

ARTICLE VIMISCELLANEOUS

The corporation shall be subject to the Alabama Nonprofit Corporation Act found at Section 10-3A-1 et. seq., Code of Alabama, 1975, or the corresponding provision of any future Alabama law.

The purposes for which the corporation is organized are exclusively religious, charitable and educational within the meaning of section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(C)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

ARTICLE VIIREGISTERED OFFICE AND AGENT

The address of the registered office of the corporation shall be 600 Governors Drive, S.W., Huntsville, Alabama 35801 and the registered agent shall be Alvin Pelton.
