Our Commitment to Privacy

Information We Collect

We may collect personal information that you voluntarily provide through our website, including:

- Information submitted through contact forms

Providing this information is voluntary. You may choose not to provide personal information, although some website features or ministry opportunities may be limited as a result.

How We Use Information

Online Giving

Faith Fellowship Church may offer online giving through a secure third-party provider. Financial information submitted during online giving transactions is processed by the payment provider and is not stored on our website servers.

Cookies and Website Analytics

Our website may use cookies and similar technologies to improve website functionality and user experience.

We may also use analytics services, such as Google Analytics, to collect anonymous information regarding website traffic and usage. This information may include:

- Pages visited
- Time spent on pages
- Device type
- Browser type
- General geographic region

This information helps us better understand how visitors use our website and how we can improve our online ministry.

Information Sharing

Faith Fellowship Church does not sell, rent, lease, or trade personal information to outside organizations.

Information may be shared only:

- With trusted service providers assisting in church operations

- When required by law
- To protect the safety, rights, or property of Faith Fellowship Church or others

Any third-party service providers we use are expected to maintain appropriate privacy and security standards.
