- Submit the top portion of the registration form to the Art Committee—with your artwork—on the receiving day

- Original paintings, collage, sculpture, photography, pen and ink, mixed media, prints, poetry (on 8 ½ by 11 sheets) and other creative works

- Maximum size 40” including frame

- All work should be wired for hanging (no self-hanging frames or brackets, or fragile, unstable or damaged works accepted) **Plexiglass only**

- All artwork must be picked up on the day specified. Please provide a signed permission note if another person is to pick up your work.

- “NFS” (not for sale) and “POR” (price on request) items must list value on Committee copy for insurance purposes
