

Proposal: Establishing “Love Thy Neighbor” Nonprofit Initiative

Overview

“Love Thy Neighbor” is a proposed nonprofit initiative dedicated to providing direct financial assistance to individuals and families in need within our community. Rooted in compassion, faith, and service, this organization will partner closely with the local church to identify and support those facing financial hardship—particularly related to medical bills, food insecurity, and other essential living expenses.

Mission Statement

To demonstrate love in action by providing timely financial assistance and support to individuals and families in need, fostering hope, dignity, and community through faith-driven outreach.

Vision

A community where no neighbor struggles alone—where generosity, compassion, and faith unite to meet urgent needs and uplift lives.

Core Objectives

- Provide monthly financial assistance to 1–2 individuals or families facing hardship.
- Focus on essential needs such as medical expenses, groceries, rent, utilities, and emergency support.
- Partner with the church to identify, vet, and support recipients.
- Encourage community involvement through donations, volunteering, and prayer.

Program Structure

1. Monthly Assistance Program

Each month, selected recipients will receive financial support funded through donations. The amount may vary depending on available funds and individual needs.

2. Nomination & Selection Process

- Candidates may be nominated by church members, community members, or church leadership.
- A small review committee (comprised of church leaders and nonprofit representatives) will evaluate applications based on urgency, need, and available funds.
- Priority will be given to individuals experiencing unexpected hardship.

3. Distribution of Funds

- Payments may be made directly to service providers (e.g., hospitals, utility companies), when possible to ensure funds are used as intended.
- ◆ Or direct payment to families or individuals.

Partnership with the Church

The church will play a central role in:

- Promoting the mission and encouraging donations.
- Helping identify individuals in need.
- Providing volunteers and administrative support.
- Offering spiritual guidance and community connection for recipients.

Funding Strategy

- Weekly or monthly church offerings designated for the nonprofit.
- Community donations (online and in-person).
- Fundraising events (e.g., charity dinners, drives, seasonal campaigns).
- Potential future grants or partnerships with local businesses.

Transparency & Accountability

- Maintain clear records of all donations and distributions.
- Provide monthly or quarterly reports to donors and the church.
- Ensure a fair and consistent selection process.
- Operate with integrity and stewardship of all funds.

Legal & Organizational Structure

- Register as a 501(c)(3) nonprofit organization.
- Establish a board of directors (including church representatives).
- Create bylaws outlining governance, mission, and operations.
- Open a dedicated bank account for nonprofit funds.
