

CAMP VICTORIA

Regulations for Use

1. Camp facility use by groups is by application only. Applications must be submitted and approved at least one month in advance. Camp Victoria, Inc and its staff reserves the right to deny use to any person or party.
2. Applications shall identify the names of all participants and a description of the activities.
3. Individual participants in your group will need to complete a consent and waiver form prior to coming. For those under the age of 18, the form must be signed by their parent or legal guardian.
4. Children 10 or under must be accompanied by their parent or legal guardian in addition to having the consent and waiver form completed.
5. All groups must provide a certificate of insurance covering all participants and name Camp Victoria, Inc and Robert and Melissa Wallingford, as additional insured.
6. Individuals will be required to register upon arrival. No one that has not been identified by group leader prior to arrival will be allowed to enter.
7. All activities must be planned and supervised by the group leadership to comply with our core values.
8. No alcohol, no smoking, no vaping, no use of cannabis, no drugs of any kind (except prescription medicine)
9. While there are many free-range animals at the Camp, chickens, iguanas, birds, hermit crabs, etc., and one very endearing neighborhood dog (Poncho), outside pets are only allowed on a case-by-case basis, depending on the event, and must remain on a leash.
10. Motorized vehicles are allowed only in designated areas.
11. We have a lot of space at Camp Victoria but be considerate of the neighbors when playing music, having worship services, and playing games, particularly after dark.
12. Gates will open at 8:00am and close at 6:00pm. No entry or exit outside of these hours unless coordinated with camp staff.

STATEMENT OF FAITH

SCRIPTURE

The Holy Scriptures are the inspired word of God Himself and are as relevant today as when they were written. 2 Timothy 3:16.

SALVATION

Salvation is by faith in Jesus Christ and not by works or any physical act of man himself. John 3:16, Romans 3:22-28, Ephesians 2:8-9.

GENDER

God created mankind, male and female, and exercised His unchallengeable authority at conception. Genesis 1:27, Genesis 5:2, Matthew 19:4.

MARRIAGE

True marriage, and the only one recognized by the camp, is an institution ordained by God between one man and one woman. Genesis 2:24, Matthew 19:5, 1 Corinthians 7:2.

HUMAN SEXUALITY

Legitimate sexual relations are strictly between a married man and his wife. 1 Corinthians 7:2-4.

OUR STATEMENT OF PURPOSE

The primary purpose of the Camp is to provide a comfortable space and facility for Baptist churches and associations to use in worship, evangelism, teaching, discipleship, and recreation, particularly in their ministries with children.

The Camp invites other Christian churches and associations and also civic groups to use the camp facilities, when available, provided that their use and objective is in acknowledgment and strict accordance with the Statement of Faith.

The Camp Director and Camp Coordinator have the authority and responsibility to refuse use of the Camp to any person, church, association, or group that cannot or will not, by statement or action, comply with the Statement of Faith and Statement of Purpose.

The Camp Board of Directors shall be the final authority, in the event of a challenge in the interpretation of the applied Biblical principles summarized in the Statement of Faith and the Statement of Purpose.
