- SECOND CHILD IN GRADES K3-8TH, RECEIVES ~10% DISCOUNT ON TUITION
- APPLICABLE TO ALL ADDITIONAL K3-8TH GRADE STUDENTS

## RAISERIGHT (SCRIP) PROGRAM

- PURCHASE GIFT CARDS FOR COMMON EXPENSES SUCH AS GROCERIES, GAS, DINING, AND SHOPPING
- A PERCENTAGE OF EACH PURCHASE IS RETURNED AND APPLIED DIRECTLY TOWARD TUITION
- 96% OF THE FUNDS EARNED THROUGH THE PROGRAM ARE APPLIED AS A TUITION DISCOUNT
